2. Hazard identification:

No particular hazards known.

3. Composition/information on ingredients:

Chemical nature: - Aqueous polymer dispersion.

4. First-aid measures:

General advice: Remove contaminated clothing.

If inhaled: Keep patient calm, remove to fresh air, and seek medical attention.

On skin contact: Wash thoroughly with soap and water.

On ingestion: Rinse mouth immediately and then drink plenty of water, seek medical attention.
